Full Support for OFTA's FTTB/H Building Registration Scheme

(2nd December 2010) City Telecom (H.K.) Limited, HKEX: 1137, NASDAQ: CTCL and wholly owned subsidiary Hong Kong Broadband Network Limited (HKBN). We are in full support of The Office of the Telecommunications Authority's (OFTA) new initiative to promote the installation of fibre-based broadband access networks in residential buildings through the introduction of a voluntary building registration scheme.

As per OFTA press release http://www.ofta.gov.hk/en/press_rel/2010/Nov_2010_r1.html, "The Scheme will also encourage building management offices ("BMO") / Incorporated Owners ("IO"), as well as property developers, to meet the aspirations of our citizens to increase broadband connectivity, by retrofitting existing buildings with and to give due priority in new developments to the provision of the Networks respectively. For a building which is listed in the register, the IO/BMO may display prominently inside the building the appropriate label authorized by OFTA. They may also use the label in printing materials which they may publish in relation to the buildings." Please see Appendix for OFTA authorized Fibre-To-The-Building and Fibre-To-The-Home Labels.

With over 1.77 million homes pass with FTTB/H, HKBN is the leading provider of Fibre based residential broadband services in Hong Kong. Per FTTH Council Asia's Global Ranking, Hong Kong ranked 3rd in the World in June 2010 with 34% household penetration, or about 800,000 total FTTH users, of which HKBN has over 500,000.
